

REGATTA MALTA – REGATTA ROWER REGISTRATION FORM

[Form approved in August 2025]

Club with which registration is being made*: Siggiewi Rowing Club

The undersigned (hereinafter referred to as the “Regatta Rower”, see details on page 2 of this registration), with the consent of his/her parents and/or guardians in the case of a minor under 18 years of age, hereby declares that he/she is registering as a regatta rower with the above-mentioned Club until he/she reaches the age of 25 (in the case of a person under 25 years of age on the date of signing), or for a period of 3 years from the date of signing (in the case of individuals over 25 years of age on the date of signing) and that there is nothing to prevent him/her from being registered with this Club until the date of expiry of this contract. Moreover, it is being confirmed and agreed that:

- (a) The information in this registration form is correct, and the *Regatta Rower* undertakes to inform *Regatta Malta* when there are any changes to this information.
- (b) The *Regatta Rower* undertakes to always act with integrity and uphold the principles of fair play, honesty, and respect in all rowing activities, specifically by (i) competing cleanly and ethically, without the use of prohibited substances or methods; (ii) rejecting any form of cheating, match-fixing, or manipulation of results, (iii) respecting fellow athletes, officials, and the spirit of the sport, and (iv) reporting any known or suspected breaches of integrity to the appropriate authority.
- (c) The *Regatta Rower* will abide by all the regulations of the Club with which registering is being made and those of *Regatta Malta* including the code of discipline as well as any national regulations issued by the competent entities such as AIMS, *Regatta Malta*, or SportMalta. These entities reserve the right to change their regulations over the years as and when they deem it best.
- (c) The *Regatta Rower* is willing to submit to antidoping tests if/when requested and undertakes to be aware of antidoping regulations and abide with them.
- (d) The *Regatta Rower* undertakes to be aware of, and to abide by, all laws and regulations relating to sea and/or the use of boats in the harbour and that they will comply with the instructions given to them by Transport Malta, the police, the army, and other competent entities. The *Regatta Rower* is aware that any violation of these regulations and laws on their part may lead to fines, which fines must be paid by the *Regatta Rower*, and/or prison sentences.
- (e) The *Regatta Rower* consents to *Regatta Malta* for storing and using the information submitted in the registration form and passing it on to other entities as necessary, always as permitted by the Data Protection Act. The *Regatta Rower* also consents to photos and videos being taken which may be used, stored, processed and/or given to third parties for use in publications, social and other forms of media, etc.
- (f) The *Regatta Rower* declares to be in a good state of health as normally required by a competitive athlete and able to undertake intense physical exercise. *Regatta Rower* further declares to not suffer from any health problems or impairments that could pose a danger to themselves or their teammates during training or competition.
- (g) The *Regatta Rower* fully exonerates their Club, *Regatta Malta* as well as the committee members, administrators, directors, members and/or employees of their Club and/or *Regatta Malta* from any material, physical, moral, or other damages that the *Regatta Rower*, their family and/or dependents may suffer.
- (h) The *Regatta Rower* agrees to make good any damages suffered by their Club, *Regatta Malta* as well as the committee members, administrators, directors, members and/or employees of their Club and/or *Regatta Malta* in the event that damages are caused by the *Regatta Rower's* negligence or wrongful act, including but not limited to irresponsible behaviour during a *regatta* or training, or any conduct in violation of anti-doping rules or regulations applicable to *Regatta Malta*.

The medical certificate must be renewed annually. **Regatta Rowers aged between 25 and 28 who have registered with a club before reaching the age of 25 may be subject to payment of a compensation fee as defined in the statute of Regatta Malta before registering with a different club.** The Regatta Rower's registration with the new club cannot be accepted until the previous club confirms in writing that it has received such compensation or gives permission to the Regatta Rower to register with a new club.
